Under the following terms and conditions:

VENDOR BALANCE: We try to balance our show with a limited number of vendors in each category (i.e. scale, handcrafted, manufactured, supplies, etc.) to provide an interesting and wide selection of merchandise for the customer. In fairness to all vendors, no more than 20% of your total table space may contain merchandise marked for clearance or offered at a substantially reduced price, **NO GARAGE SALE ITEMS**. Only scale miniatures, dollhouse miniatures, supplies, publications, and accessories may be sold. We also reserve the right to first come, first serve basis on applications. All items must be priced.

TABLES: Tables are 8' x 30". Fee \$110 per table and includes electricity if requested. Chairs, table signs and nametags will be provided. You must provide your own table cover that extends to the floor, lights, heavy-duty extension cords, connectors and electrical tape.

NO SUPPLEMENTAL TABLES, HOUSES OR DISPLAYS MAY BE PLACED BETWEEN, IN FRONT OF, OR BEHIND THE TABLES. Aisles must be kept open to comply with fire regulations. Nothing shall be posted, tacked, nailed, screwed, or otherwise attached to the walls, floor or furniture. Tables are to be staffed during the entire show.

Wi Fi is available in the sales room at no charge.

SET-UP/TAKEDOWN TIME: Vendors may set up from 4 PM - 7 PM, Friday, November 18, 2022 and at 7 AM on Saturday, November 19, 2022 and, must be ready by show time at 10 AM. Vendors will have from 4 PM – 6 PM after the Show for takedown.

Fees are due on registration: Make check payable to Columbus Miniature Society and Mail to: Ann Silverman, 5532 Lexington Rd. Hilliard, Ohio 43026.

BAD CHECKS: If a banking institution returns a check to us, we will return the check and contact the Vendor. The application will then be null and void, and the Vendor will be responsible for a \$35 returned check fee.

DOOR PRIZES: In your table packets, there will be a coupon for the door prize. The coupon will be collected on Saturday morning, **if you want to donate**. The coupon will then be handed out to the winner and they will come back to your table to collect the prize and turn over the coupon to you.

SMOKING IS NOT PERMITTED anywhere in the Church.

FOOD: Lunch may be purchased on the premises. Complimentary coffee and snacks will be served during set-up on Saturday morning. Any Dealer, working alone, can make arrangements with the hospitality committee for lunch delivery. Other dealers are asked to pick up their lunches from the lunch room.
